3 A Rood Awakening Ministries makes no claim that God's eternal reward of Paradise for
4 the obedient believer is in any way or in any manner dependent upon membership or affiliation
5 with A Rood Awakening Ministries.

6 **Article III (Capitalization value)**

7 The estimated value of the property at the time of the drawing of these articles is \$0.00.

8
9 **Article IV (Title of Person)**

10 The title of the person executing these Articles is Administrator. The assets of A Rood
11 Awakening Ministries belong to A Rood Awakening Ministries and not the titular head (County
12 of San Luis Obispo v. Delmar Ashurst, 146 Cal.App.3rd 380)

13 The authority of the Administrator of A Rood Awakening Ministries extends throughout
14 Arizona and also covers the members of, wheresoever dispersed across the face of the Earth
15 (Brown v. Babbit Ford, Inc. 117 Ariz. 192, 571. P.2d 689,685, & U.S. Const. Art. IV, § 2, cl. 1).

17 **Article V (Office of Administrator)**

18 **Appointment:** A Rood Awakening Ministries Members appoint the Administrator of A
19 Rood Awakening Ministries. A Rood Awakening Ministries Members appoint the Administrator
20 based upon personal qualifications of the person desiring the office of Administrator and in
21 accord with policies and procedures found in the Book of Canon Law of A Rood Awakening
22 Ministries.

23 **Voluntarily Resignation:** The Administrator may resign at any time and for any reason
24 by entering a written notice into the records of A Rood Awakening Ministries. Administrator
25 may name his own successor in office by providing A Rood Awakening Ministries with the
26 name, mailing address, other personal, qualifying information as requested by A Rood
27 Awakening Ministries, and a written statement of resigning Administrator's personal knowledge
28 regarding successor Administrator's fitness for office. may be removed from office involuntarily
29 upon presentment of a bill of particulars upon Administrator by A Rood Awakening Ministries
30 Members in accordance with the Ecclesiastical Canon Laws.

31 **Powers of Successor:** Upon effective replacement of the Administrator of A Rood
32 Awakening Ministries, the successor in office shall become vested with the title to property with
33 like powers, authorities, and immunities over the same jurisdiction and subject to the same
34 liabilities and obligations as the previous Administrator.

1 The members of A Rood Awakening Ministries are first and foremost subjects of YHVH
2 and proclaim our allegiance to Him, as He is our Creator, Master, Savior, Counselor, The
3 almighty YHVH (God) and The Everlasting Father. We derive all power and authority from
4 Him.

5 The subscriber hereto, and successors in office, shall have the power to occupy and
6 possess by donation, gift, bequest, devise or purchase; to hold and maintain property, real,
7 personal and mixed, and to grant, sell, convey, rent, or otherwise dispose of the same, as may be
8 necessary, to carry on or promote the object of the corporation, with the full right and authority to
9 borrow money, to give written declaration therefore, and secure payment thereof by mortgage or
10 other lien on real and personal property, when necessary to promote said object.

11 The right to contract and be contracted with, and to sue and be sued, plead and be pleaded
12 in all courts of justice and to use a corporate seal shall be in the same manner and to the same
13 extent as natural men and women, pursuant to Article VI herein. (The Overseers of the Poor of
14 the City of Boston v David Sears, 39 Mass (2Pick) 122 at 128).

15
16 All deeds and other instruments in writing shall be made in the name of A Rood
17 Awakening Ministries and signed by current Administrator, and to use a corporate seal, by which
18 all deeds and acts of said corporation may be authenticated.

19 A Rood Awakening Ministries shall indemnify any person who incurs expenses or
20 liabilities by reason of the fact he/she is/was an officer, director, employee, agent, or member of
21 A Rood Awakening Ministries or is/was serving at the request of A Rood Awakening Ministries
22 as a director, officer, employee, or agent of another Corporation, partnership, joint venture, trust
23 or other enterprise. This indemnification shall be mandatory in all circumstances in which
24 indemnification is permitted. The indemnification provided by this section shall not be deemed
25 exclusive of any other rights to which those benefited may be entitled under the bylaw if such
26 exist, agreement, vote of the members or disinterested Directors or otherwise, both as to action in
27 his/her official capacity and as to action in another capacity while holding such office, and shall
28 continue as to a person who has ceased to be a Director, officer, employee, agent, or member and
29 shall inure to the benefit of the heirs, executors and/or administrators of such a person.

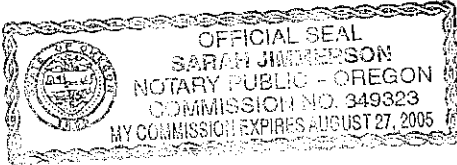



Mission Statement

I. NAME

The official name is A Rood Awakening Ministries. The name is so given to represent the ministry in a Millennium theme. A Rood Awakening Resources is the subdivision name for all scriptural, educational and audio/video tapes, books, and tours to Israel.

II. BOARD OF ACCOUNTABILITY

A Rood Awakening! Ministries shall have a board of directors composed of at least five members. The "start up" Board of Accountability shall be appointed by James Russell Louis, hereafter, new Board member are elected by a unanimous vote of the EXISTING "START UP" board.

The Board of accountability shall oversee all of the business of the ministry to ensure that the integrity of the ministry is maintained. **This includes:**

- Appointment of a Director of Operations

- Conduct monthly internet instant messaging meetings, and annual Board of Principal meetings
- The Board of Accountability may amend, modify, or replace any articles of these Operating Principles with exception of article VII.

PRESIDENT

Michael Rood is the President. Definition of President:

1. The visionary who sets the general direction and vision of the ministry
2. The one whom has the initial revelation of this work of the Ruakh
3. The President and founder Michael John Rood shall serve as President of A Rood Awakening Ministries until such times he resigns or is unable to perform this function, a new president will be appointed by the Board.
